

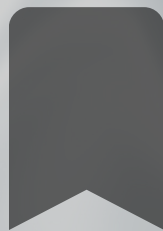

# **INTRODUCTION**

**A Marriage-Based Green Card allows the spouse of a U.S. citizen or lawful permanent resident to live and work permanently in the U.S.**

**But the key to approval?**



**Submitting a complete, well-organized, and authentic documentation set.**

**This checklist will help you prepare all the essential documents for a smooth application process.**

## **STEP 1: PROOF OF A LEGAL MARRIAGE**

**To prove your marriage is legally valid, include:**

- 1 Certified Marriage Certificate (translated if not in English).**
- 2 Divorce decree(s) or death certificate(s) from previous marriages (if any).**
- 3 Name change records (if applicable).**



**Tip: Ensure your marriage certificate includes official signatures and registration details.**

## **STEP 2: PROOF OF A GENUINE RELATIONSHIP**

**USCIS looks for proof that your marriage is real, not just for immigration purposes.**

**Include:**

- 1 Wedding & couple photographs.**
- 2 Joint lease, mortgage, or utility bills.**
- 3 Joint bank account statements.**
- 4 Insurance policies showing spouse as beneficiary.**
- 5 Travel itineraries, messages, or shared memberships.**



**The more genuine your evidence, the stronger your case.**

## **STEP 3: IDENTITY & CIVIL DOCUMENTS**

**Each spouse must submit:**

- 1 Passport (biographic page).**
- 2 Birth certificate.**
- 3 Government-issued ID.**
- 4 Two passport-style photos (per applicant).**
- 5 Police clearance (if required by country of residence).**



**Tip: Ensure all copies are clear and unexpired.**

## **STEP 4: FINANCIAL SUPPORT DOCUMENTS**

**The U.S. citizen or Green Card holder must prove financial ability to support their spouse using Form I-864 (Affidavit of Support).**

- 1 Last 3 years of tax returns (Form 1040).**
  - 2 W-2s or pay stubs.**
  - 3 Employment verification letter.**
  - 4 Bank statements showing financial stability.**
-  **Joint sponsors can help if income is insufficient.**

## **STEP 5: IMMIGRATION FORMS CHECKLIST**

**Essential USCIS forms for a marriage-based Green Card include:**

- **Form I-130: Petition for Alien Relative**
- **Form I-130A: Supplemental Information**
- **Form I-485: Adjustment of Status (if spouse is in the U.S.)**
- **Form I-864: Affidavit of Support**
- **Form I-693: Medical Examination Report**
- **Form I-765: Work Authorization (optional)**
- **Form I-131: Advance Parole (optional)**

## **STEP 6: INTERVIEW PREPARATION DOCUMENTS**

**For the Green Card interview, bring:**

- **Original passports & IDs**
- **Interview appointment notice**
- **Marriage certificate (original)**
- **Updated relationship evidence (recent photos, joint bills, etc.)**
- **Copies of submitted USCIS forms**



**Transparency and legal consultation are crucial before reapplying.**

## **STEP 7: ADDITIONAL SUPPORTING DOCUMENTS**

**Optional but helpful documents include:**

- **Social media posts or correspondence showing genuine relationship**
- **Evidence of financial interdependence**
- **Children's birth certificates (if applicable)**



**Be honest, confident, and concise. | Officers value authenticity.**

## **BONUS: 214(B) DENIAL EXPLAINED**

**Section 214(b) means:**



**You failed to convince the officer that you are a genuine temporary visitor.”**

**It is not a permanent ban. You can reapply after addressing the officer’s concerns with stronger documents and a refined case strategy.**
